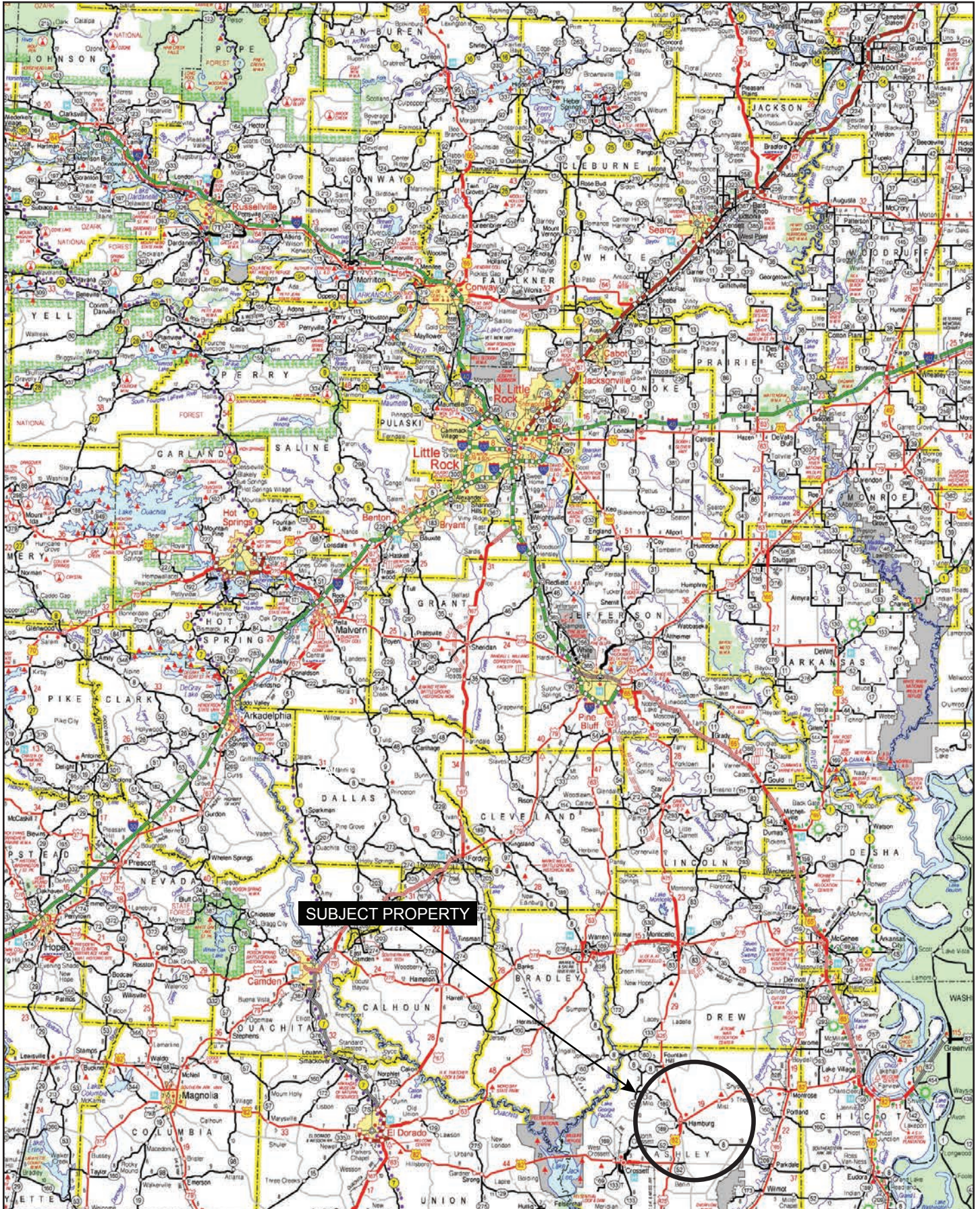

VICINITY MAP



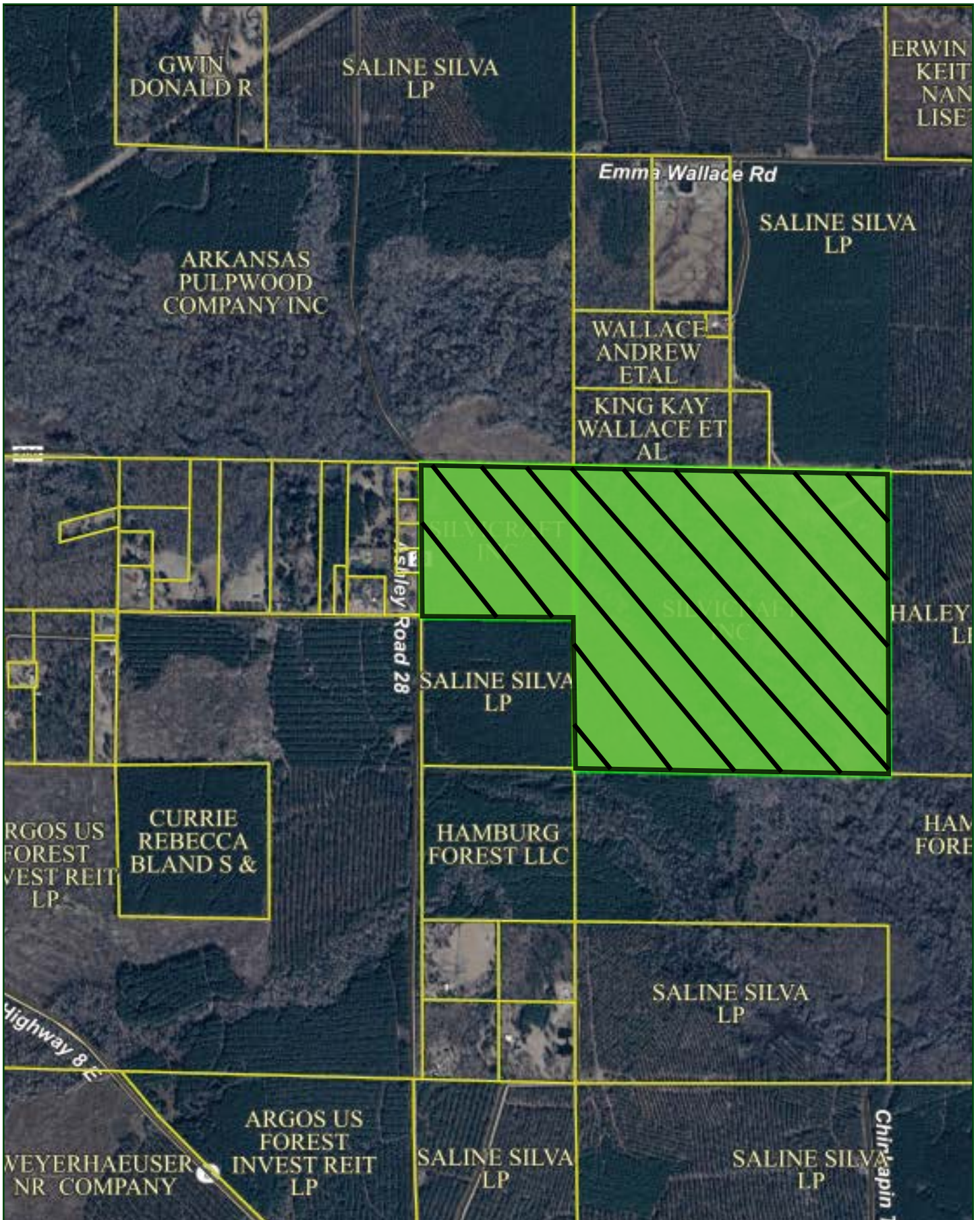

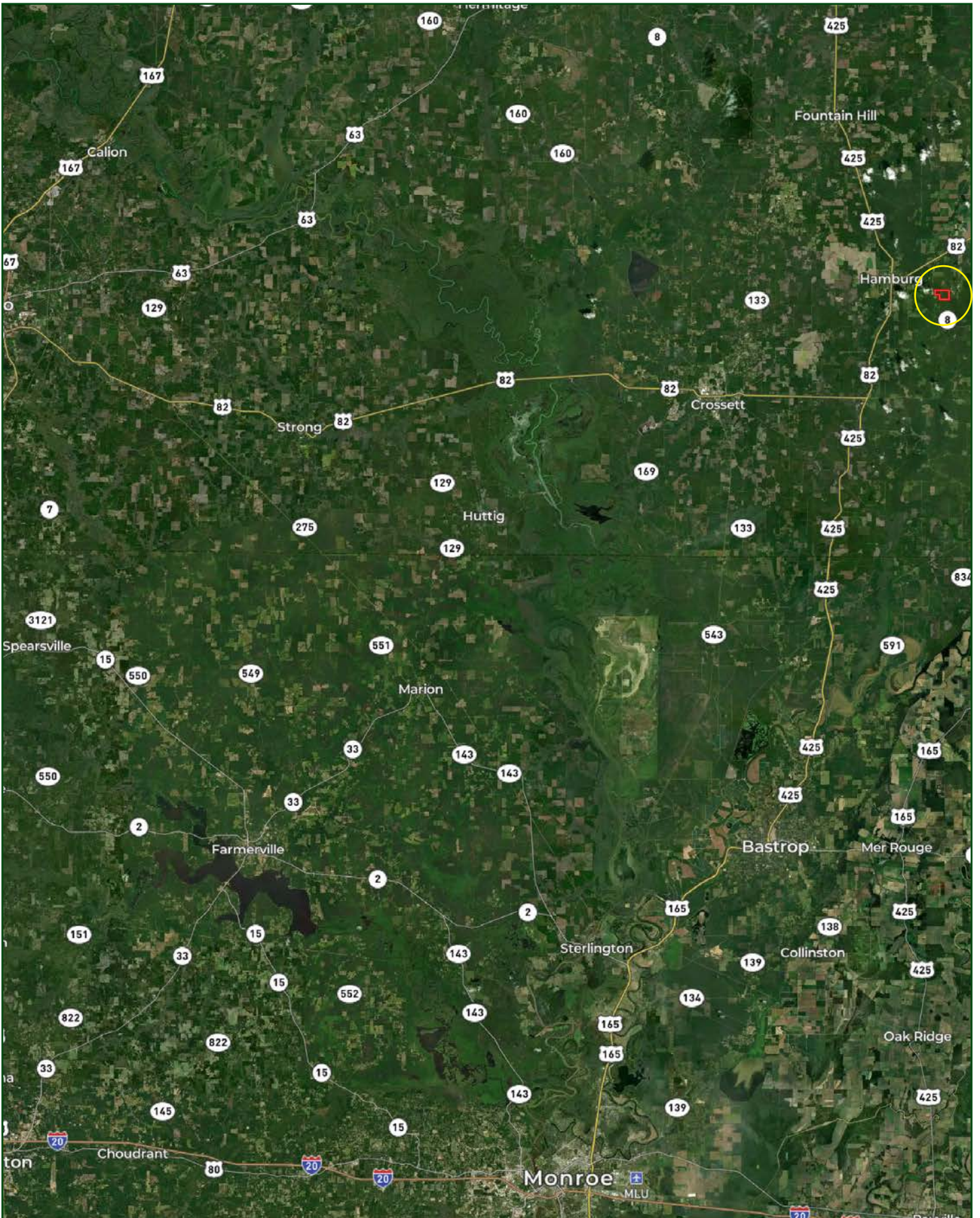

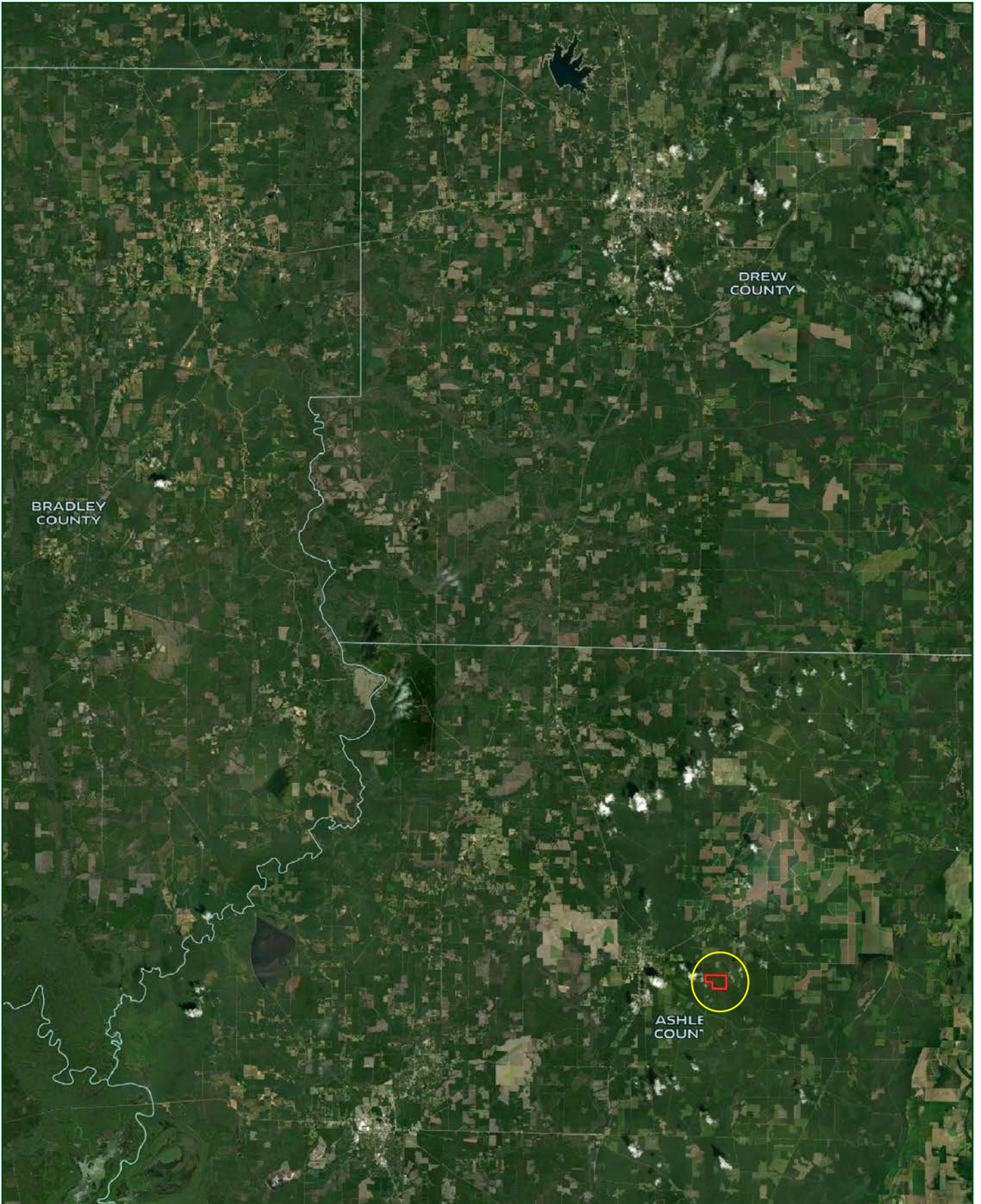
OWNERSHIP MAP



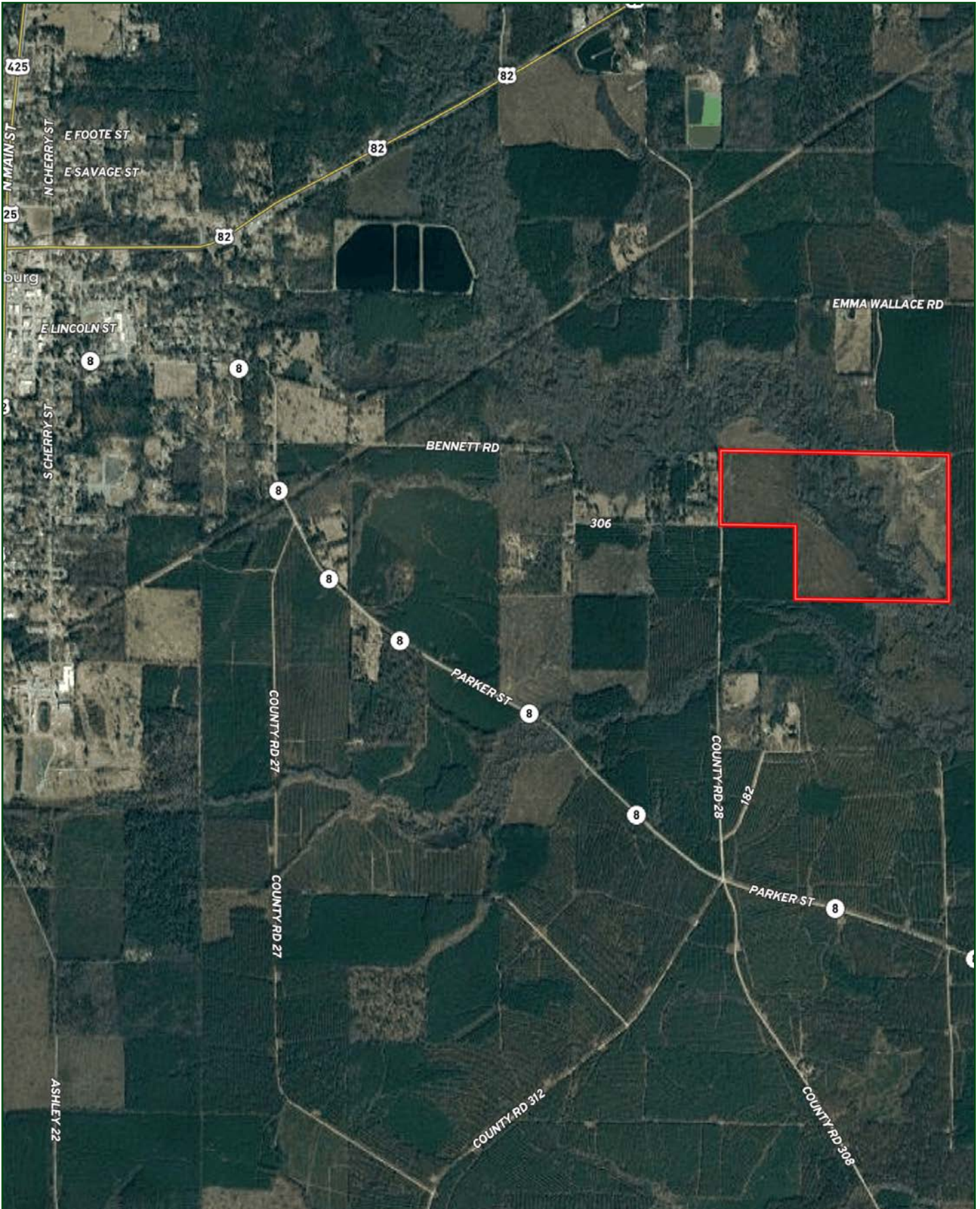
LOCATION MAP



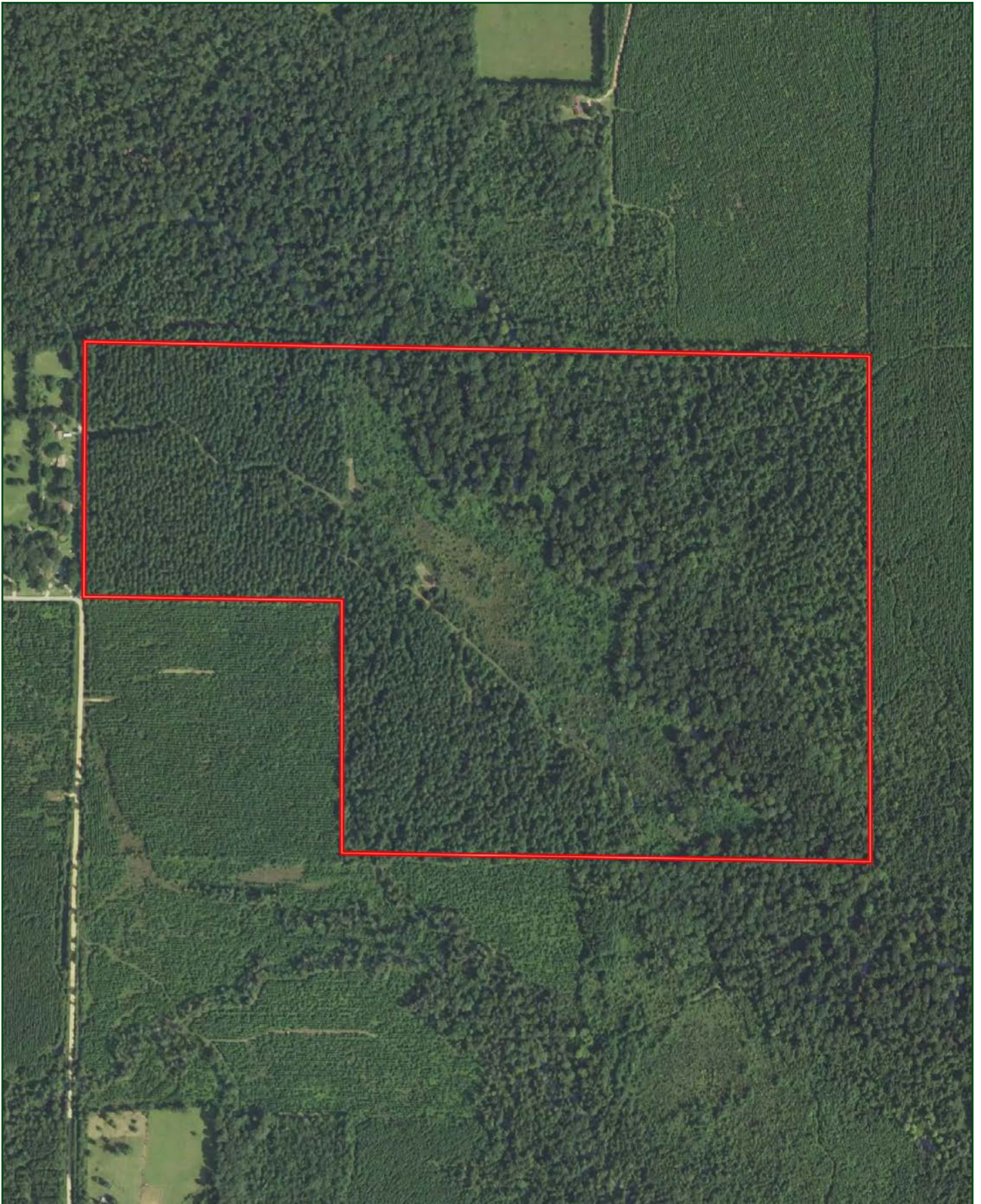
COUNTY MAP



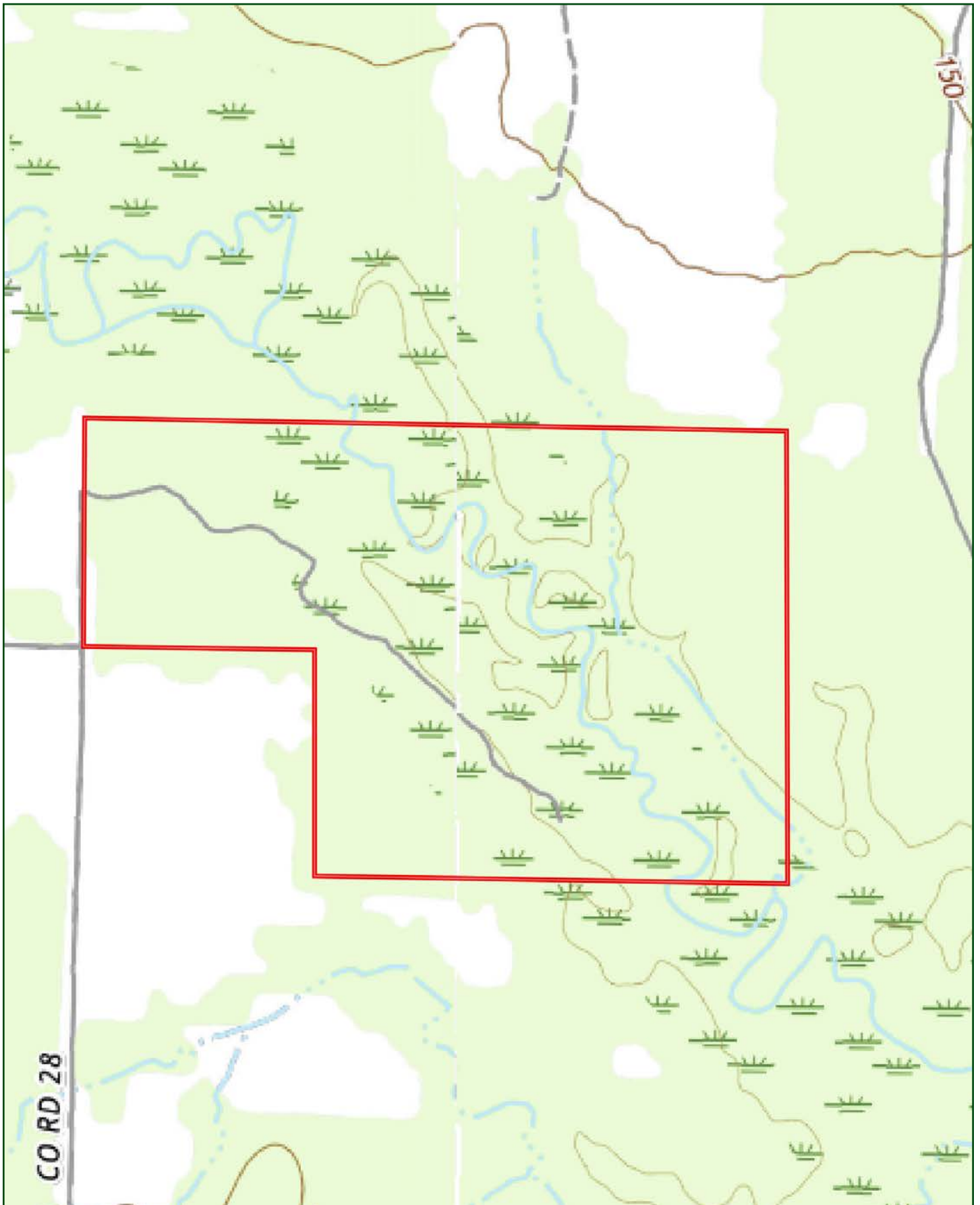
AERIAL MAP
