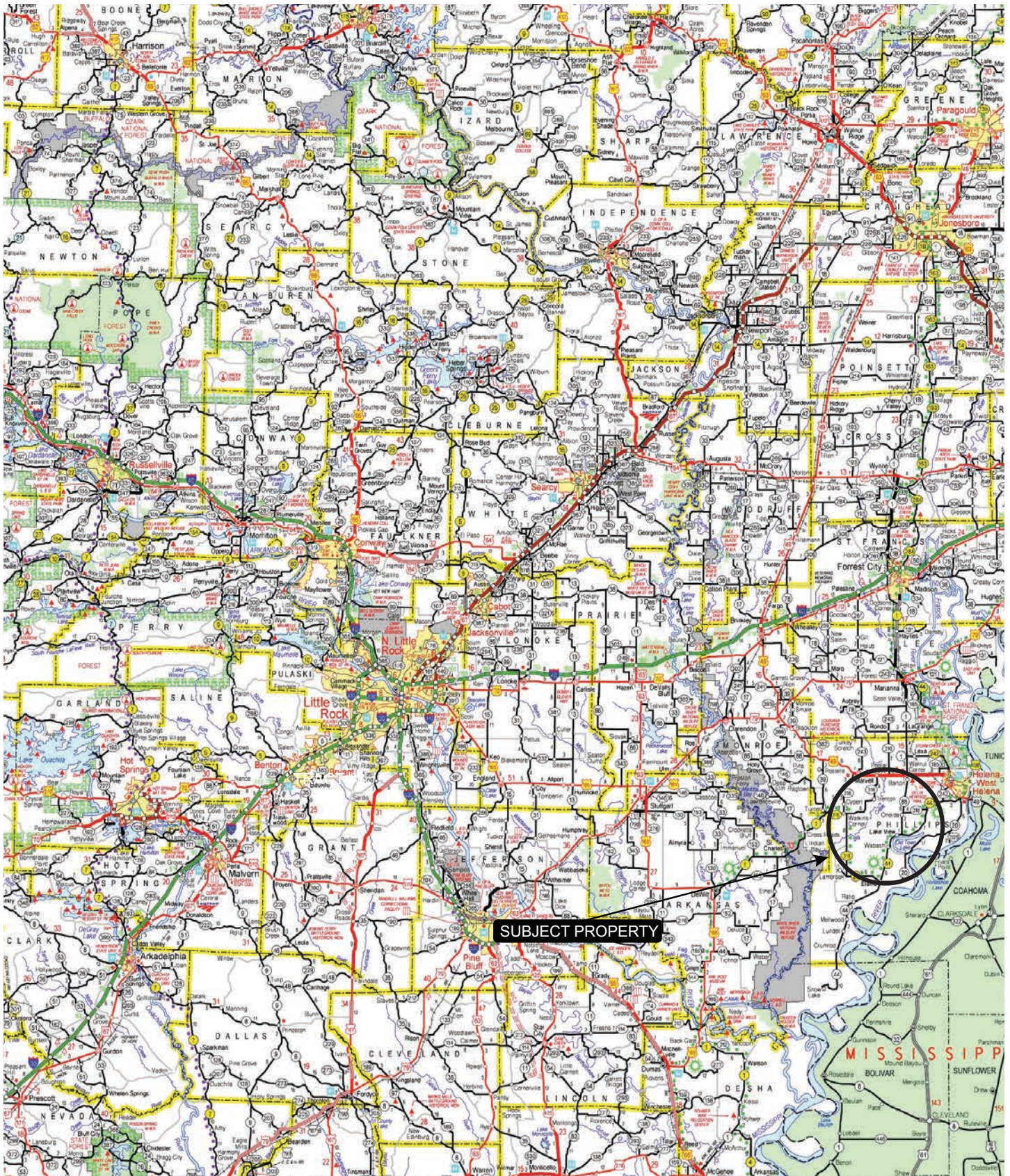

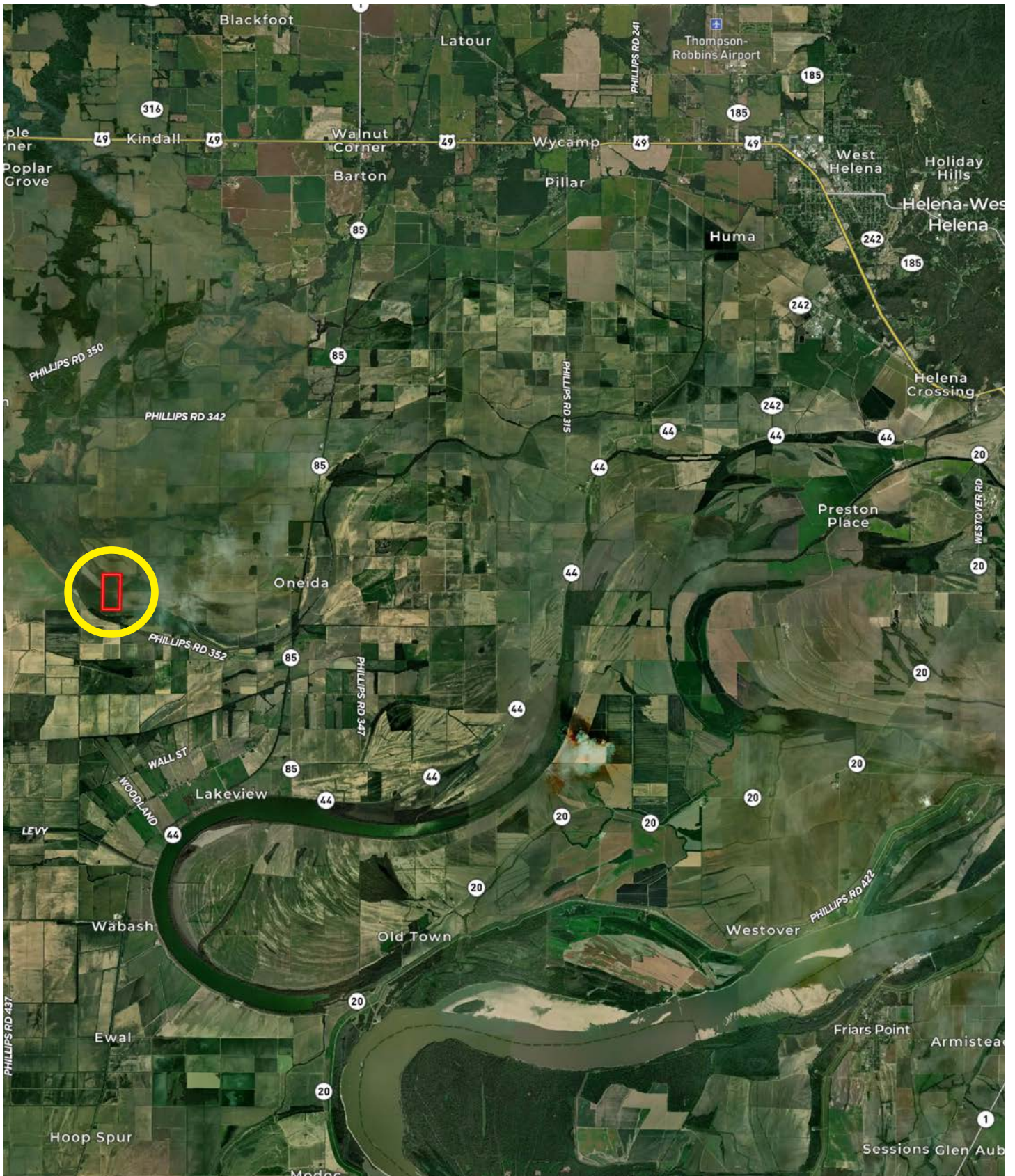
BEAVER BAYOU FARM

The Beaver Bayou Farm is located in Phillips County, Arkansas and is an excellent agricultural and recreational investment opportunity. The property consists of 84.38± acres, all of which are tillable per the Farm Service Agency (FSA). The tillable acres are split into two fields and fully irrigated by the diesel turbine well. The historical crop rotation is rice and soybeans.

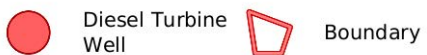
Both fields have been leveled to a zero grade and there is a duck blind in place on the north side of the property. Recreational opportunities on the property include deer, duck, and small game hunting. Access is considered excellent from a deeded easement off of Phillips County Road 346.

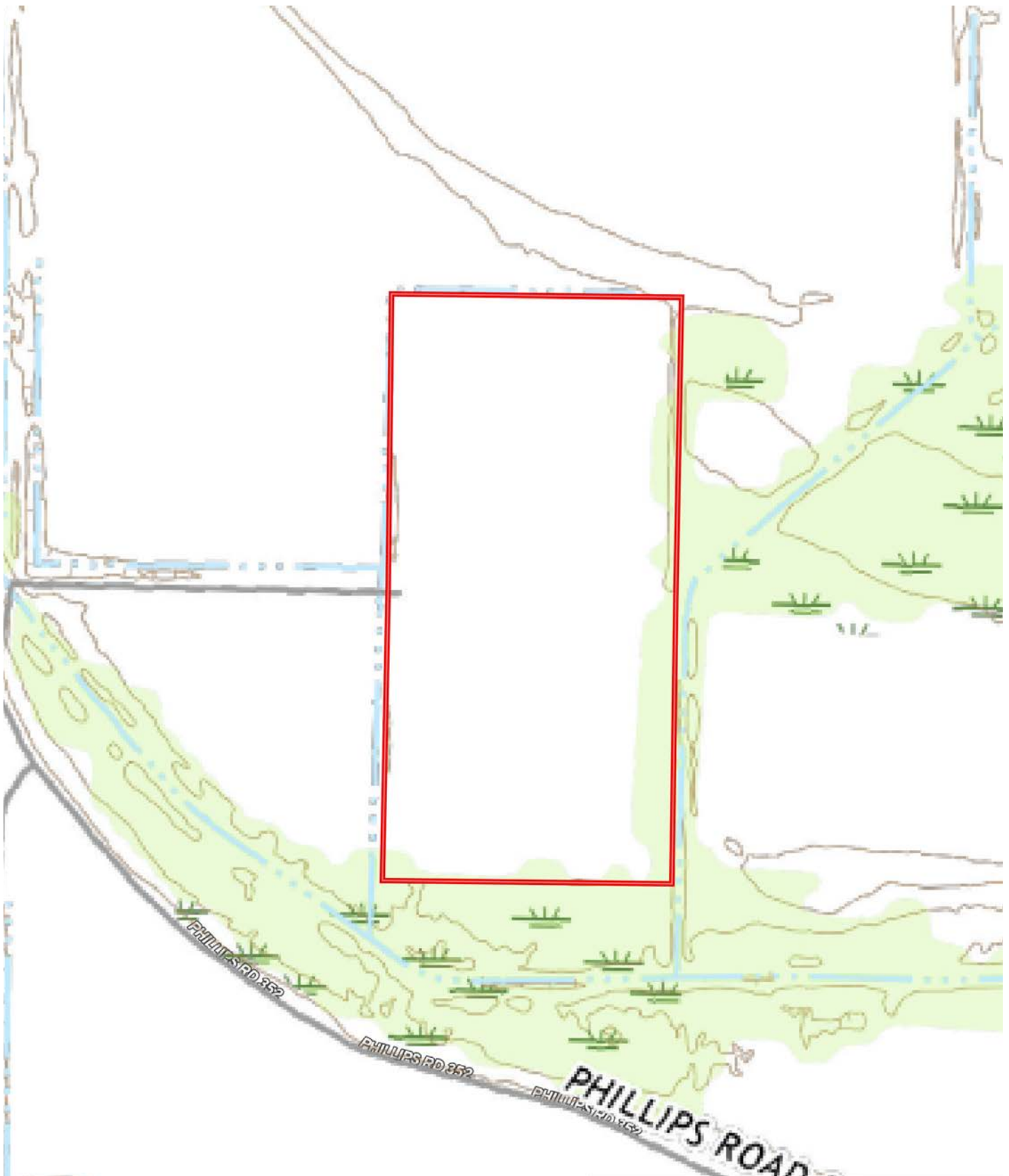
