

The property consists of $360\pm$ acres, more or less, located in Jefferson County, just east of Pine Bluff along the Arkansas River. Approximately $153.17\pm$ acres were recently enrolled in the Conservation Reserve Program that will produce good annual income over the next fifteen years. This acreage will be planted in hardwoods in the winter of 2024 which will provide additional habitat for whitetail deer. A neat feature of the property is the "island" that has over $6,000$ feet of frontage along the river and a $10\pm$ acre food-plot. Great deer hunting opportunities exist on the property in addition to fishing and water sports available on the river. Located in the southern portion of the property is $4\pm$ acre headquarter site which offers a great area to build a camp, or store equipment.




