

The stocking is primarily loblolly pine that has been naturally regenerated with scattered mixed species hardwoods. Elevations vary with the 350' elevation line bisecting the ownership, opportunity to build a pond does exist. Recreational hunting is also an option. This property would lend well to be used as a home site, timberland investment, recreational retreat, or all

combined.




#### OWNERSHIP MAP




#### OWNERSHIP MAP
