

**Description:** 

The Big Creek Timber Tract offers a good recreational and timberland investment opportunity located in Prairie County, Arkansas just 3.5 miles south of the community of Des Arc. Consisting of 68.72± surveyed acres, the property is a unique mix of beautiful bottomland hardwoods in addition to 30 acres of mature pine plantation that is enrolled in the Conservation Reserve Program. The acreage enrolled in CRP has recently been renewed meaning the acreage will continue to produce good annual income through 2032. Approximately 21± acres in the northwest portion of the property is enrolled in the Wetland Reserve Program. An excellent feature of the property is a very nice residential / camp building site located on the highway frontage with direct access to public water and electricity. The site features beautiful oaks and has recently been cleared and prepped. With the property's proximity to the Dagmar WMA, Raft Creek WMA, Black Swamp, White River Refuge, and Cache River Refuge it is an ideal location for a base camp. In addition to great deer hunting, the property also provides overflow duck hunting in the northwest corner when the White River is up.

**Recreation:** Deer, turkey, and duck hunting opportunities exist on the property.






#### OWNERSHIP MAP
