

The Walters Farm consists of approximately 280± acres located in Johnson County, Arkansas just south of the community of Hartmann in the Arkansas River Valley. The Farm Service Agency office reports a total of 268.18± cropland acres that are non-irrigated with the exception of approximately 120± acres on the west tract which are irrigated by an eight (8) inch diesel turbine well. The tillable acreage was leased to Estep Farms on a 75 / 25 crop share with shared expense for the 2023 crop year with full details provided below. The west tract has good access from County Road 2120, and the other two tracts are accessed by private roads.






