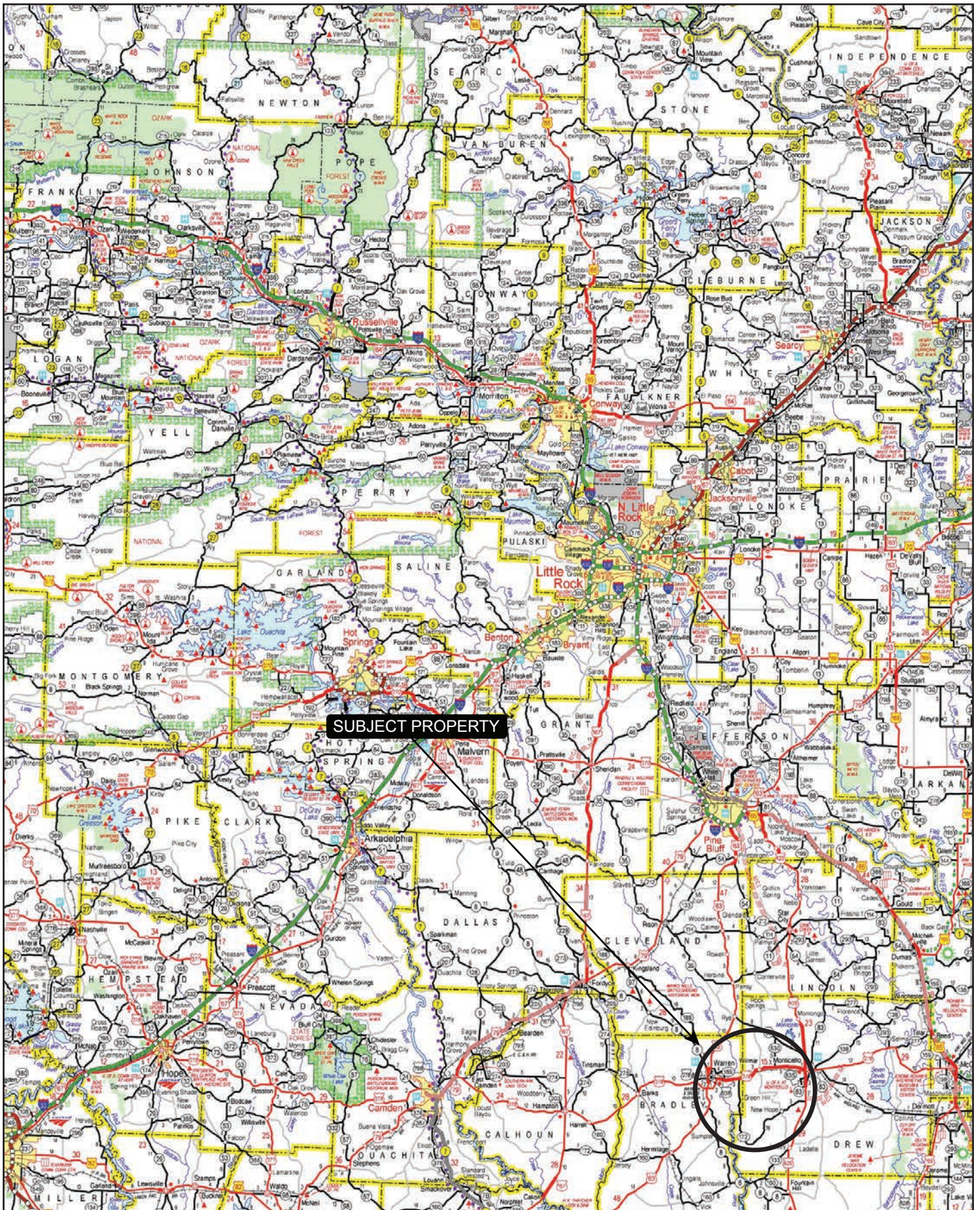

VICINITY MAP



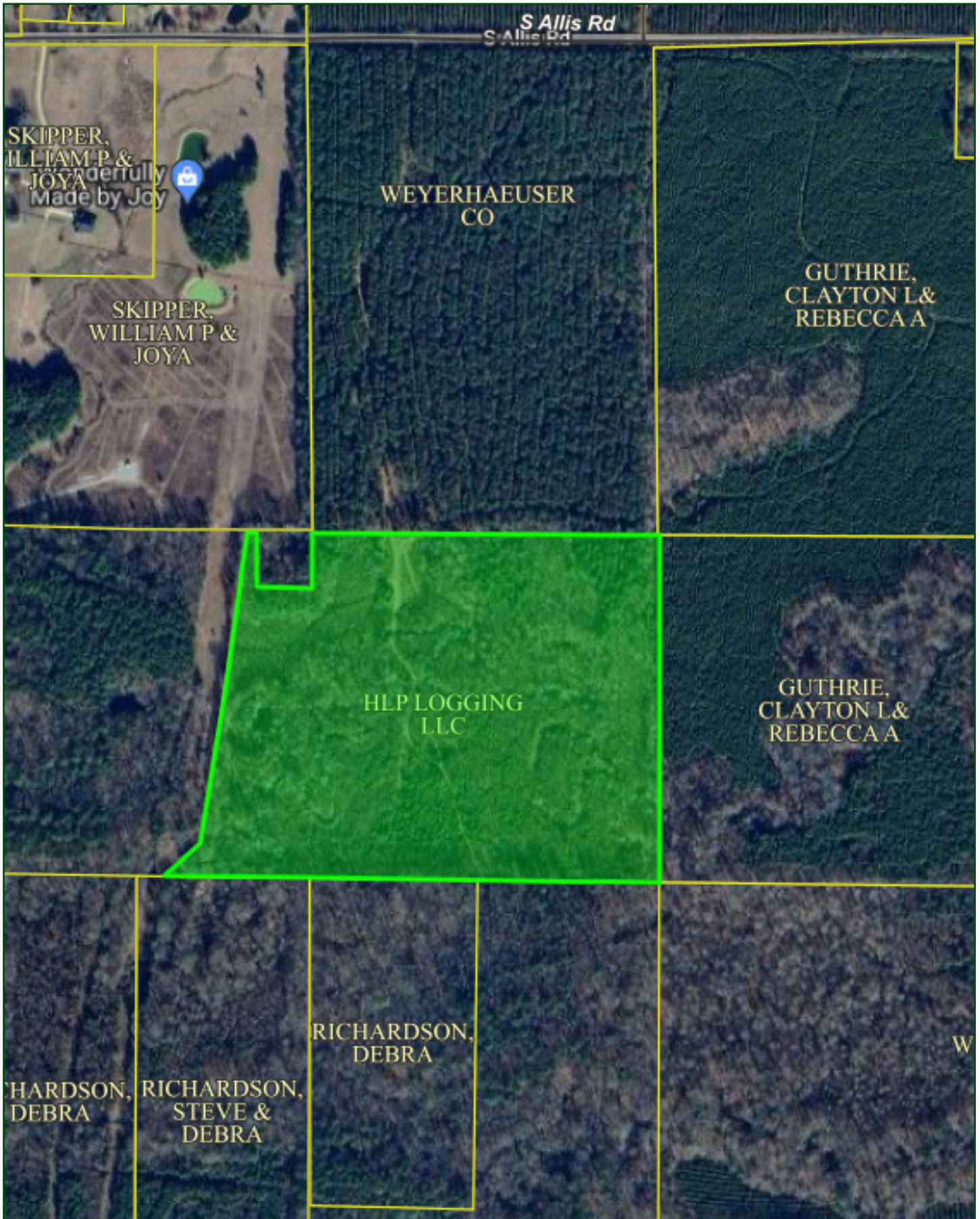

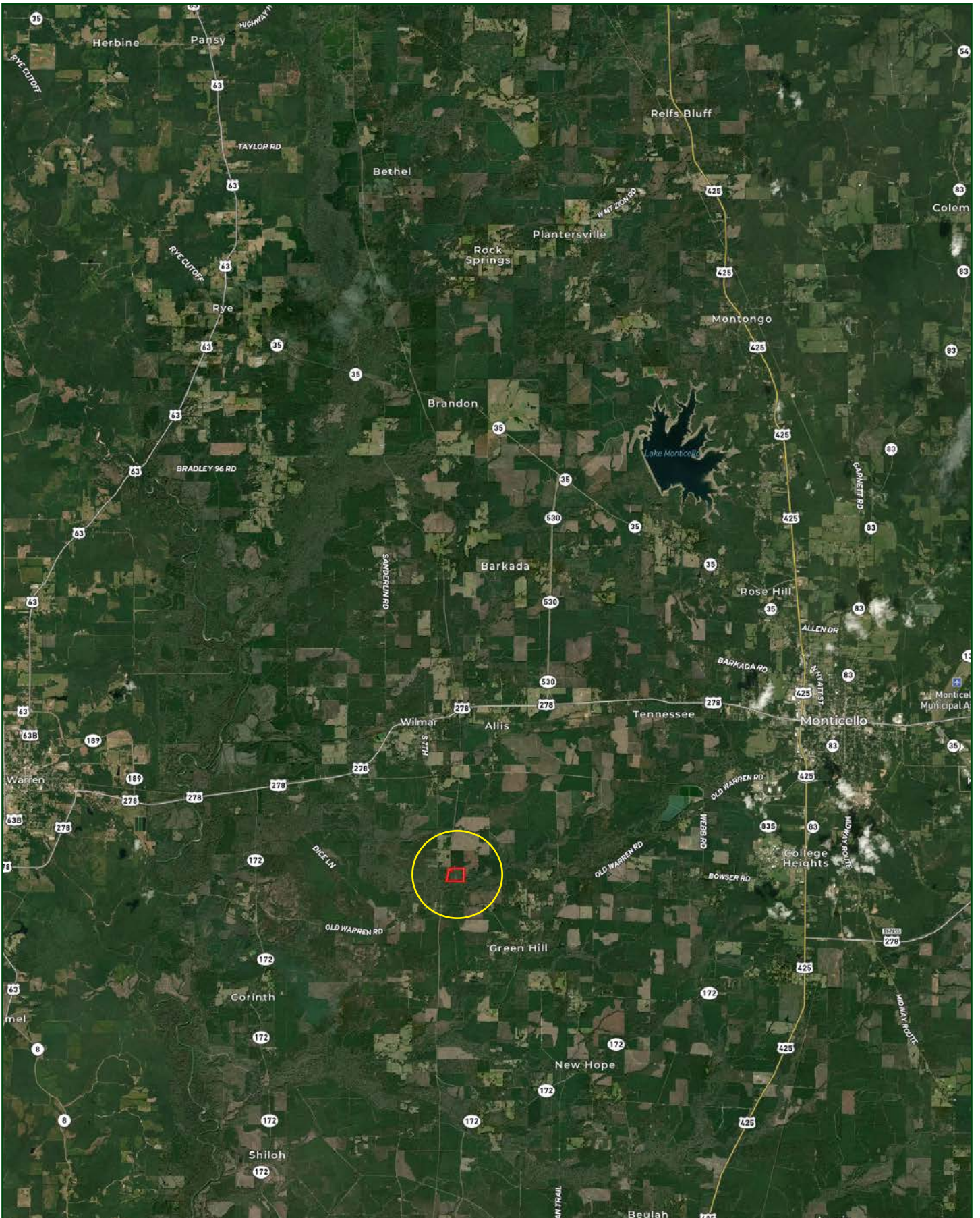

LOCATION MAP



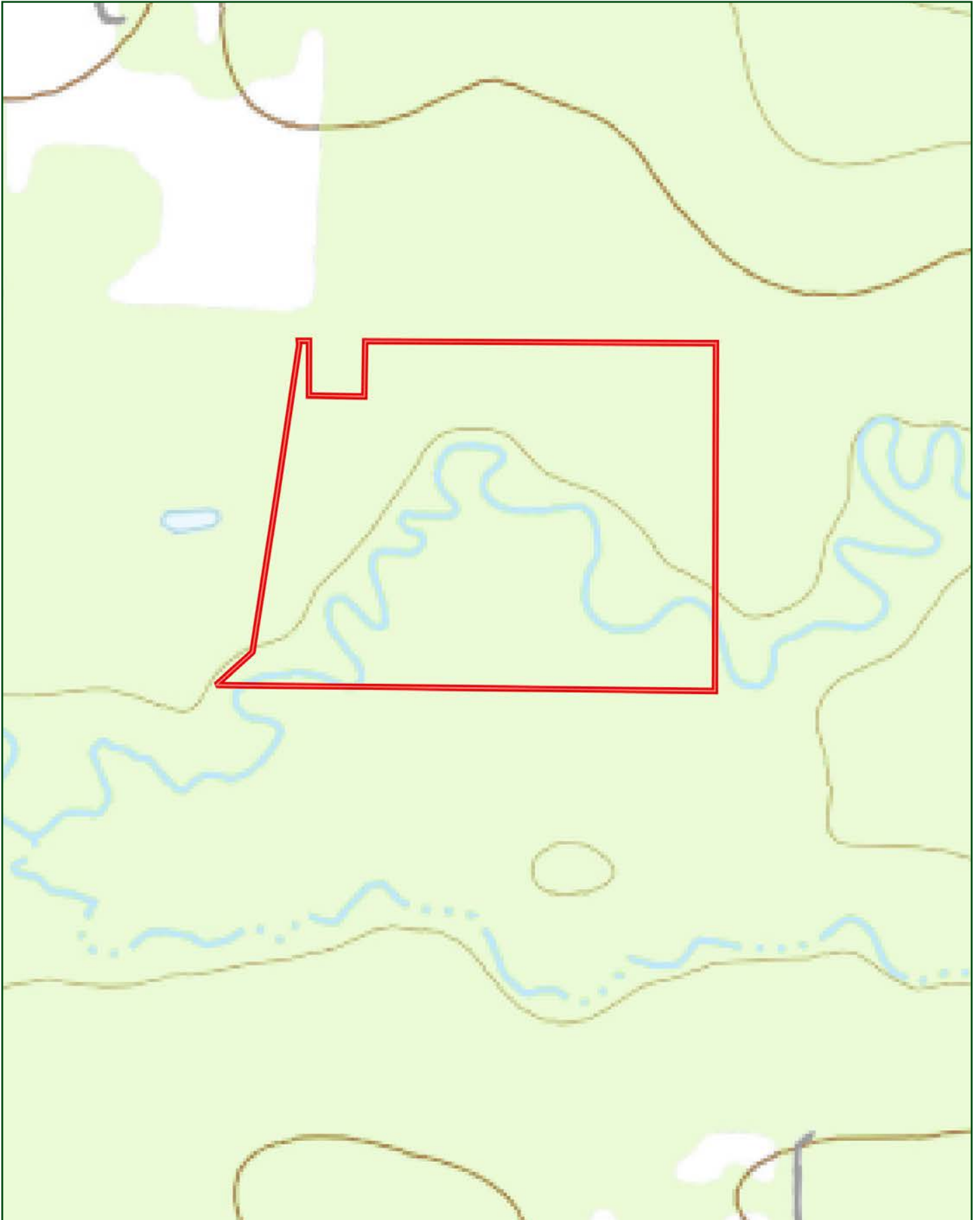




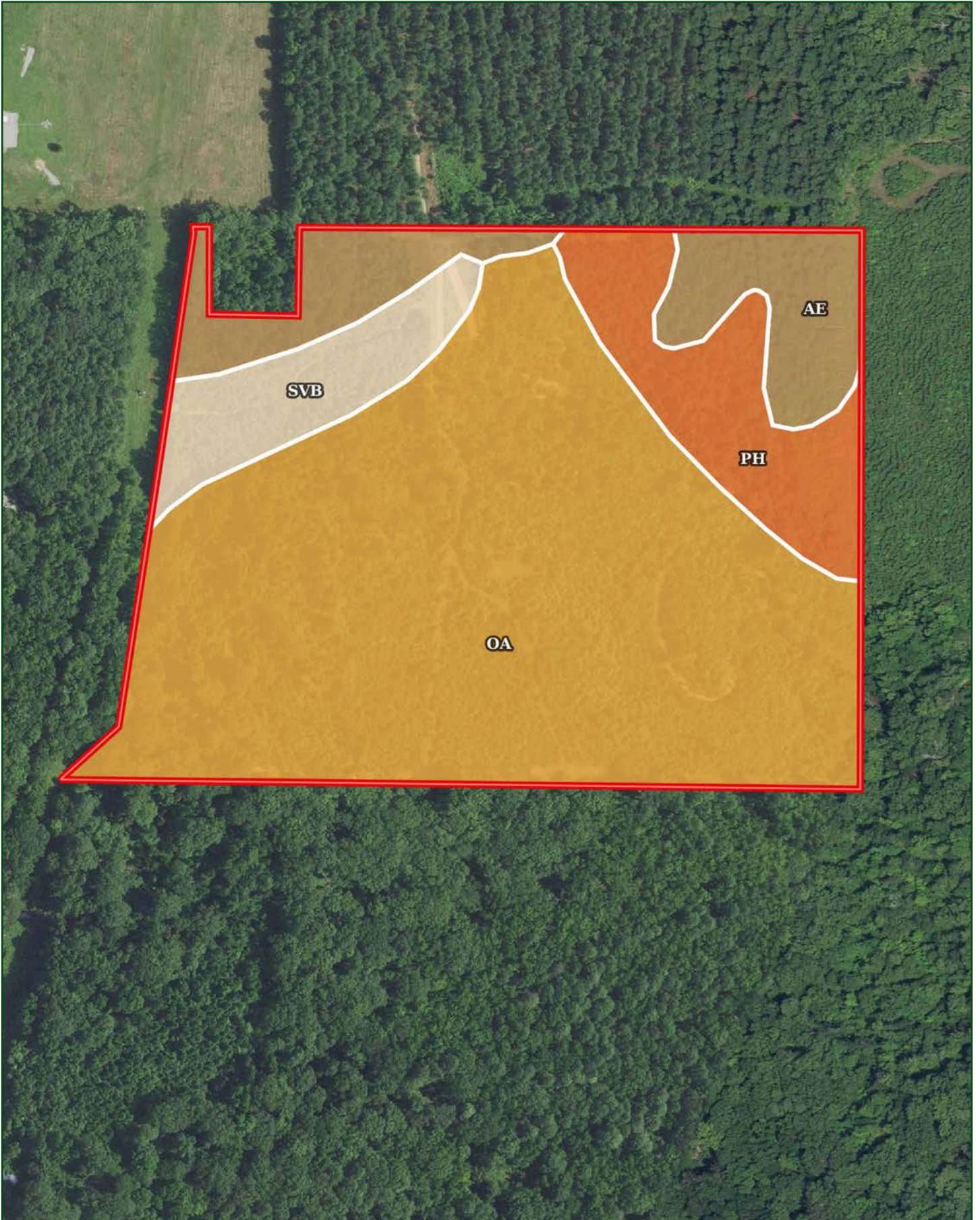




TOPOGRAPHY MAP
